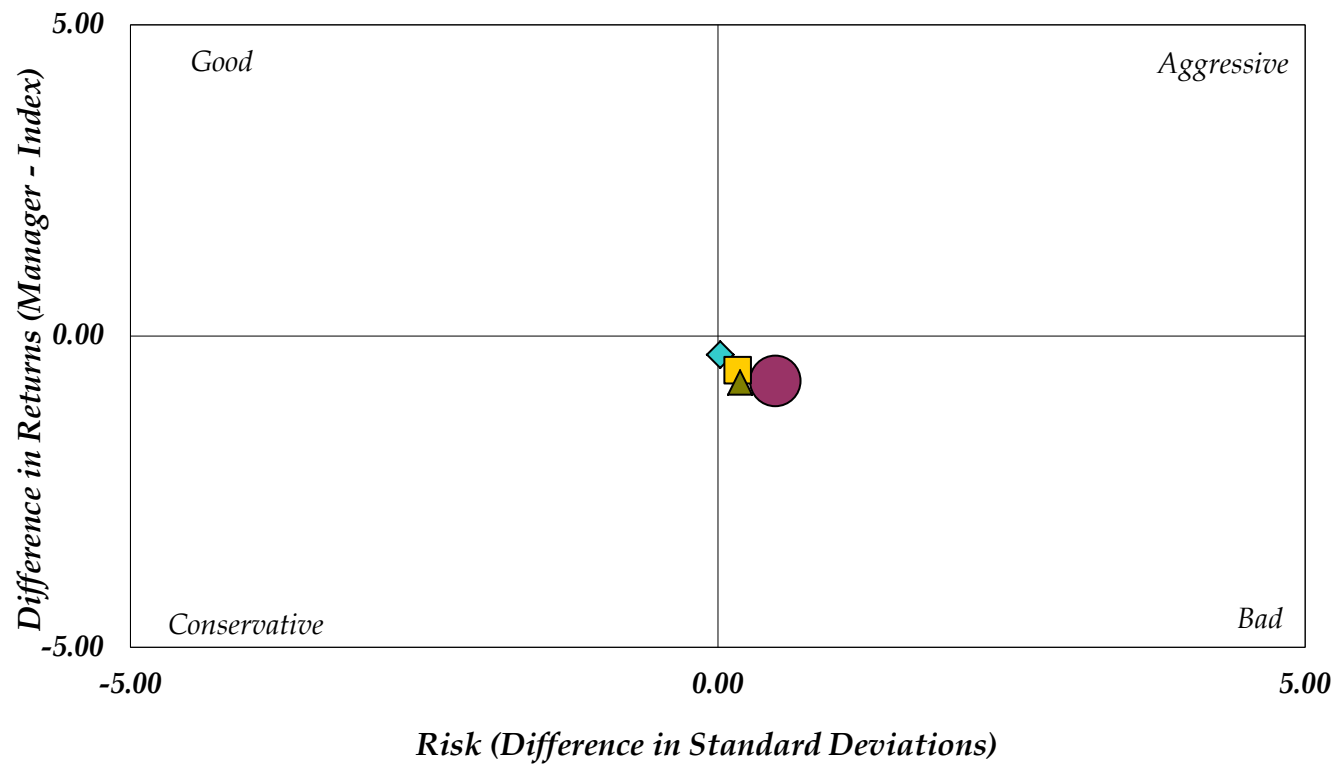

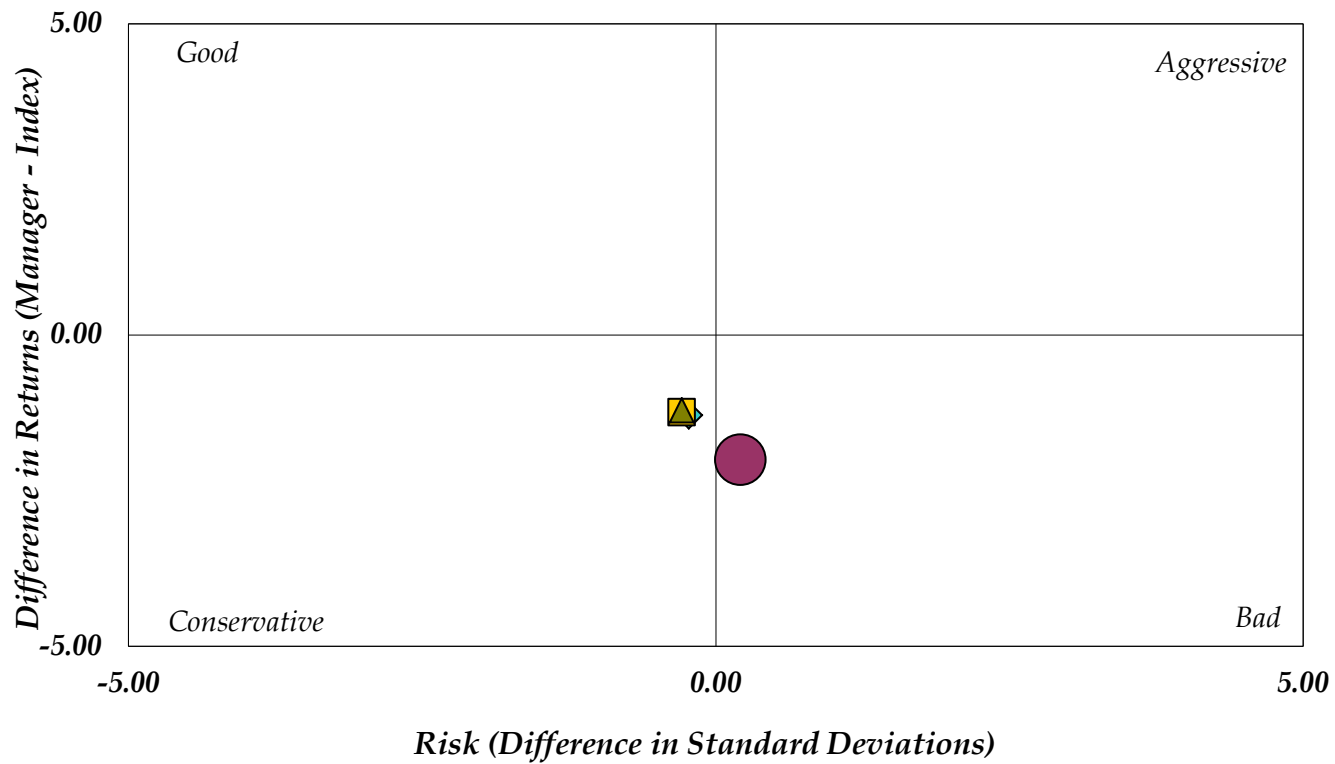

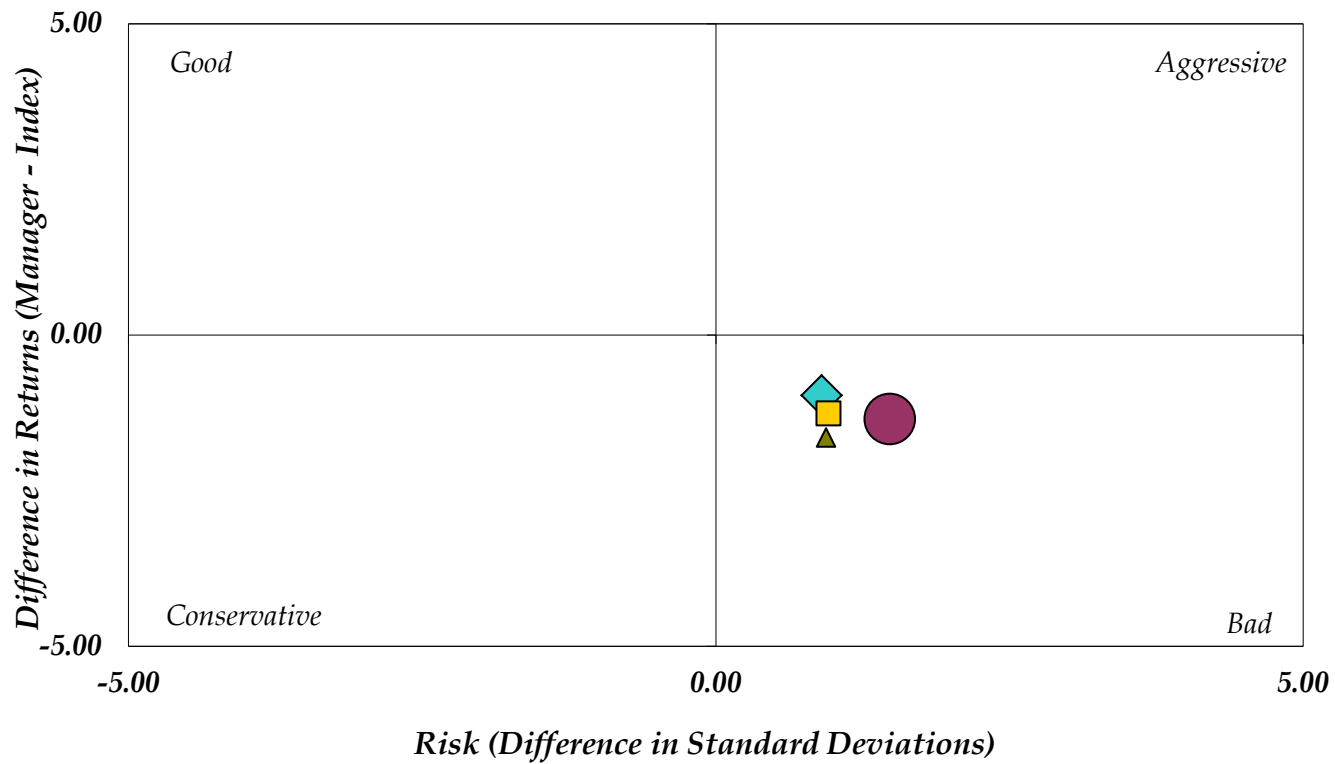

(versus S&P 500)*

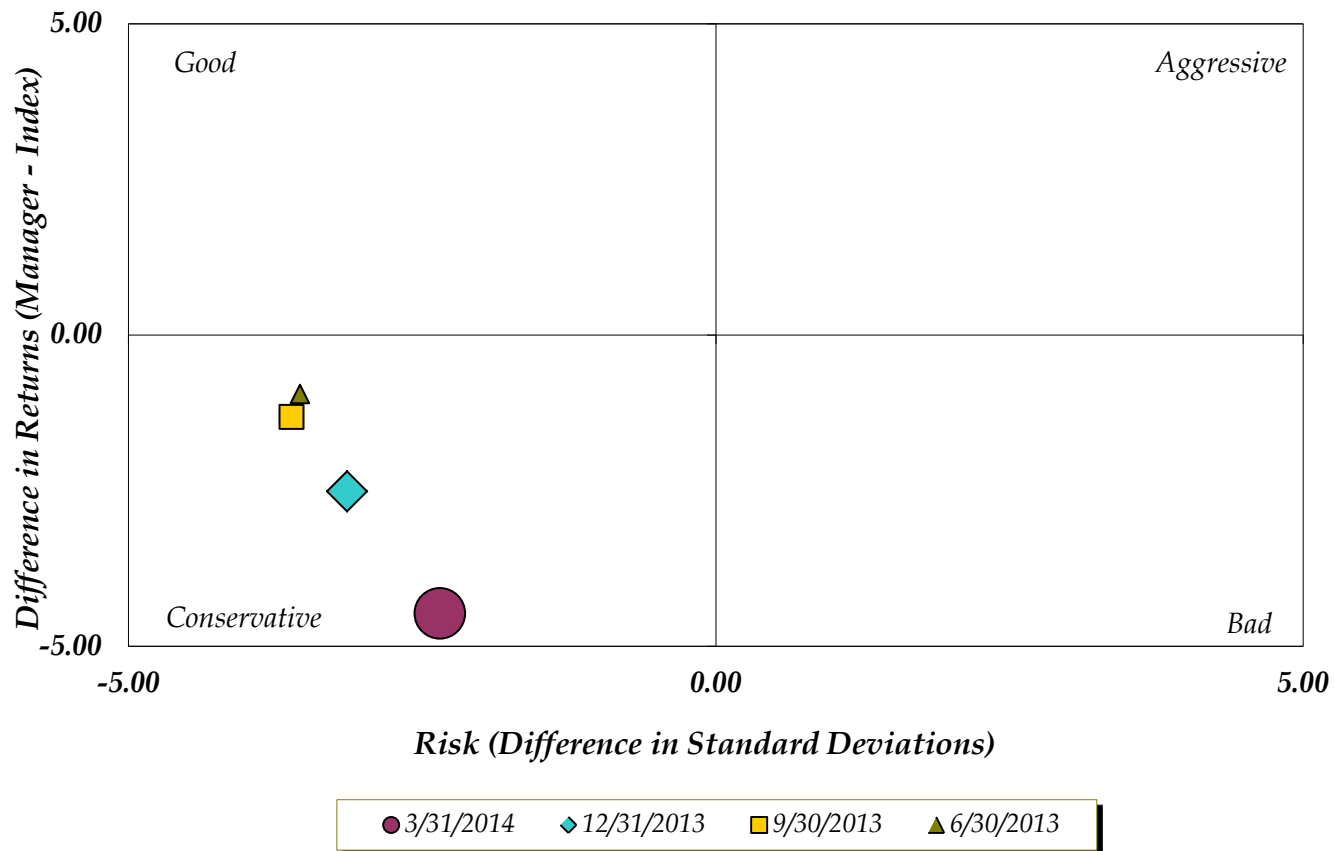

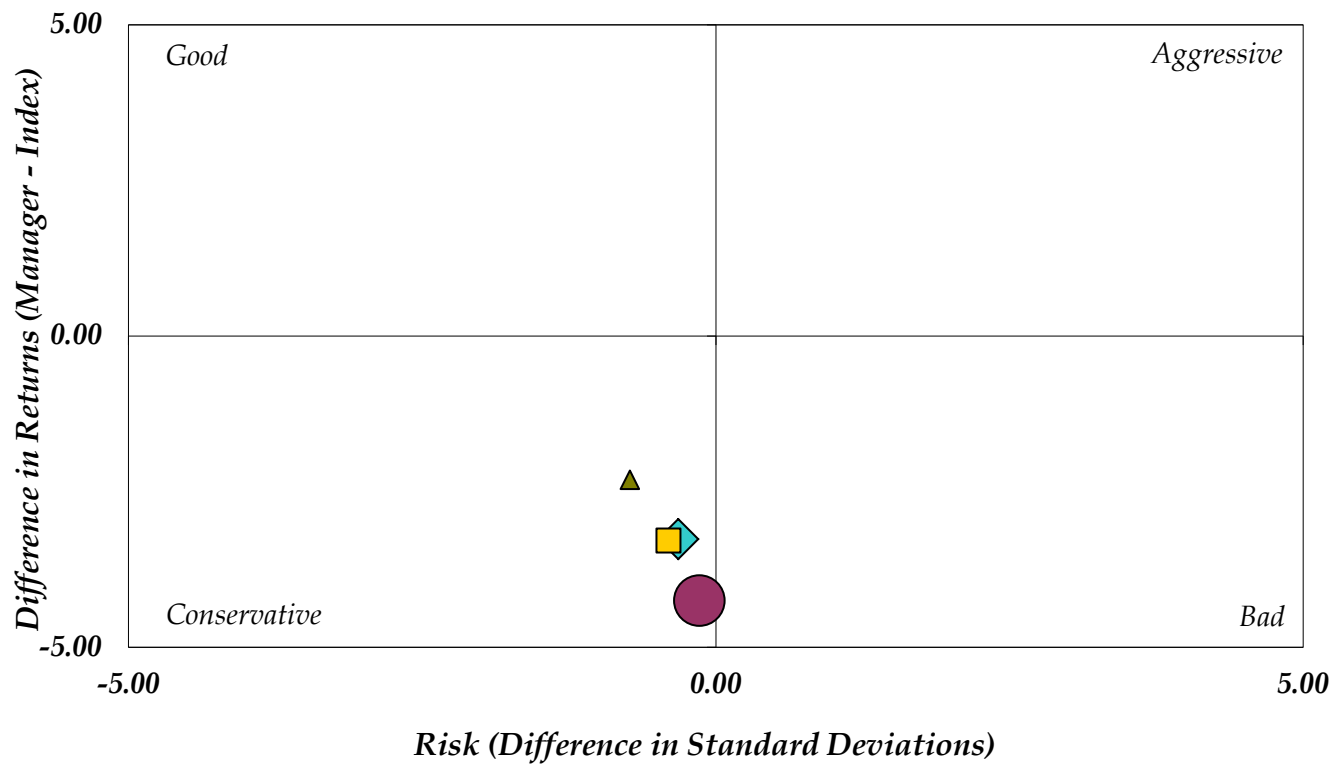

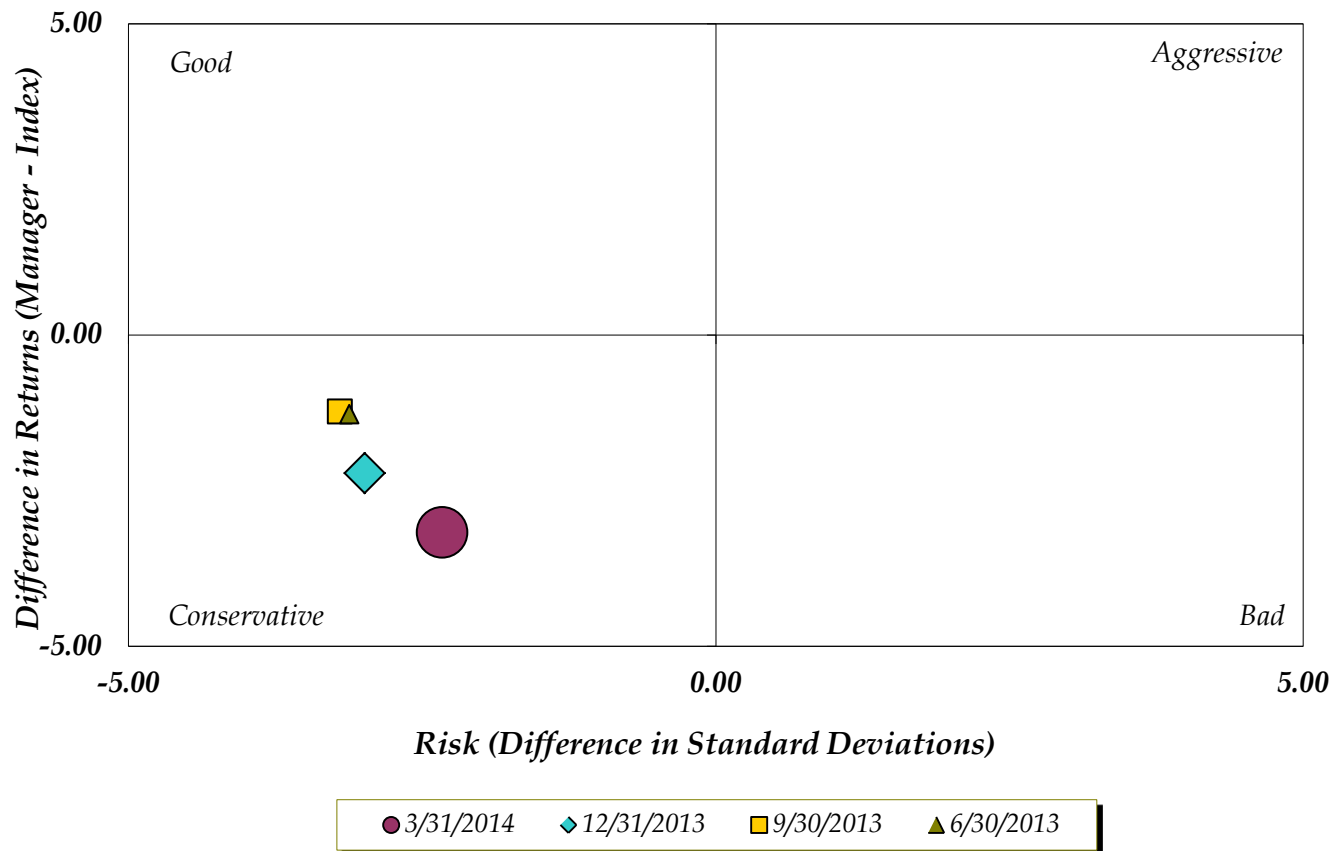

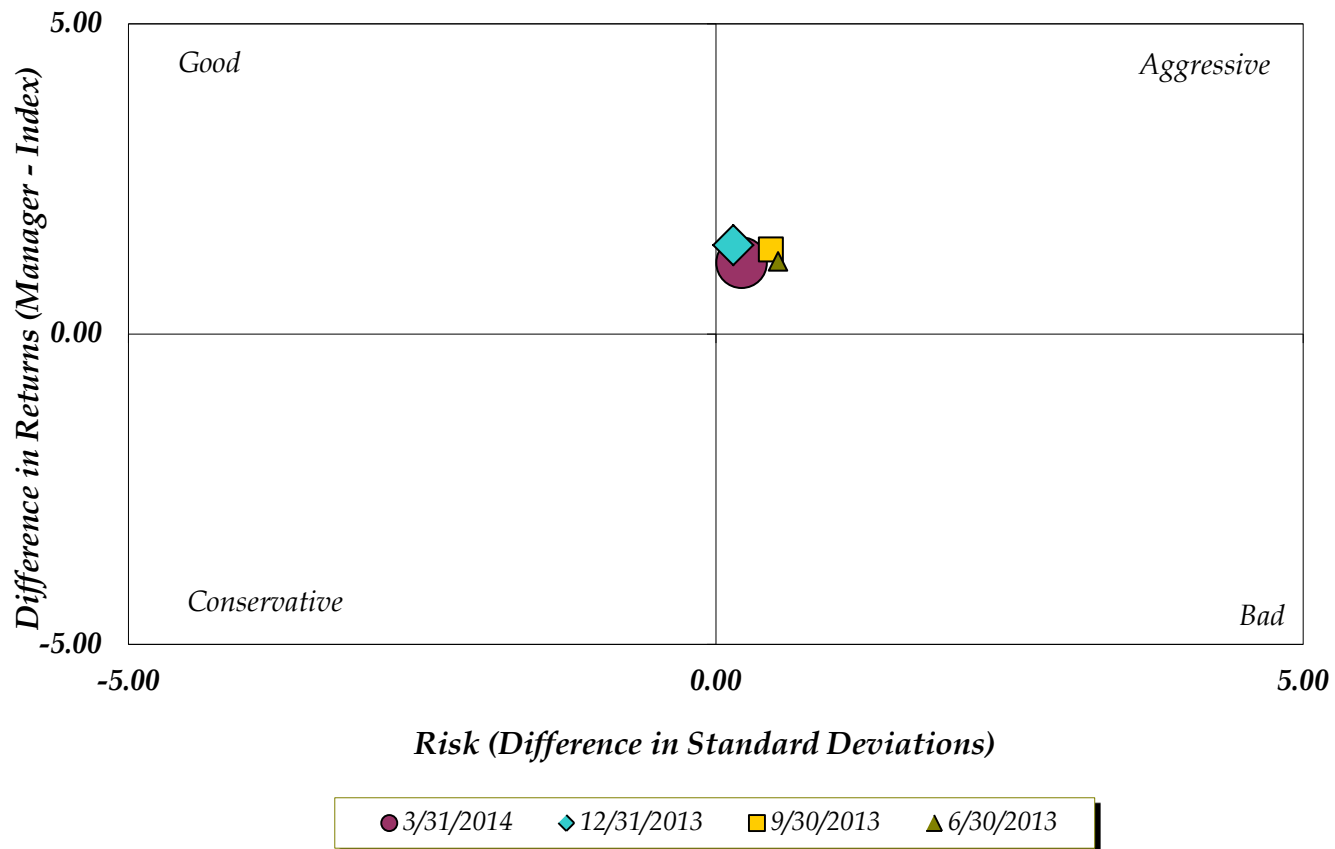

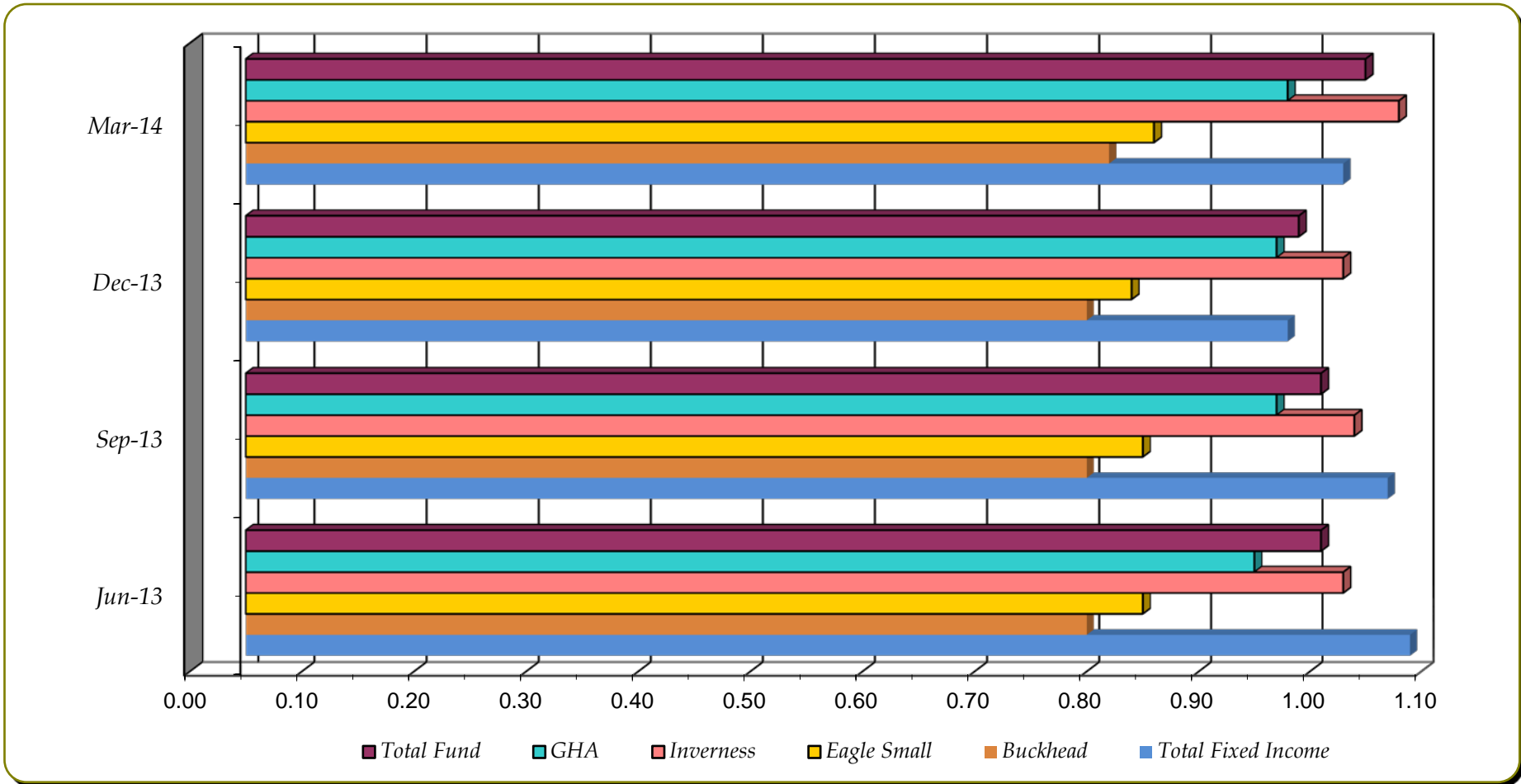

*Beta: Trailing 5-Year Risk*

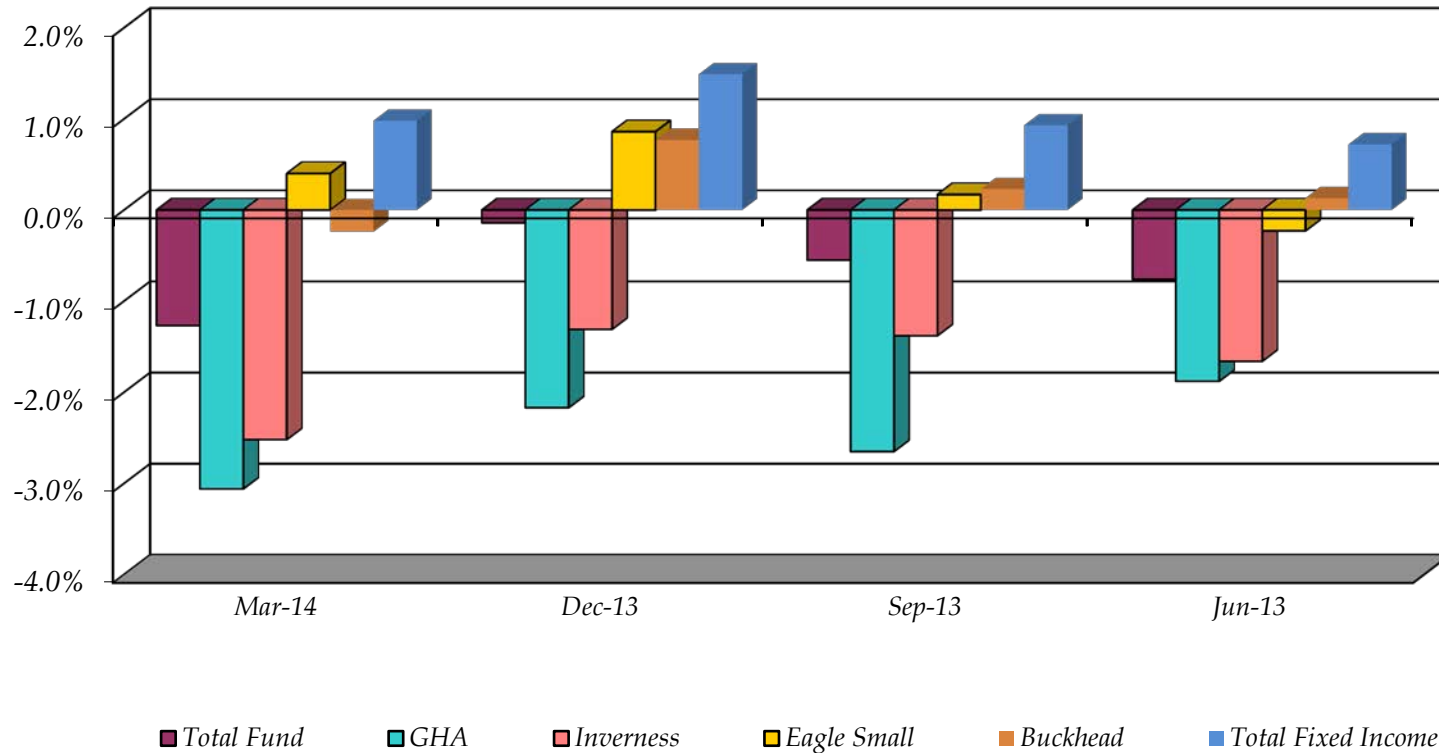

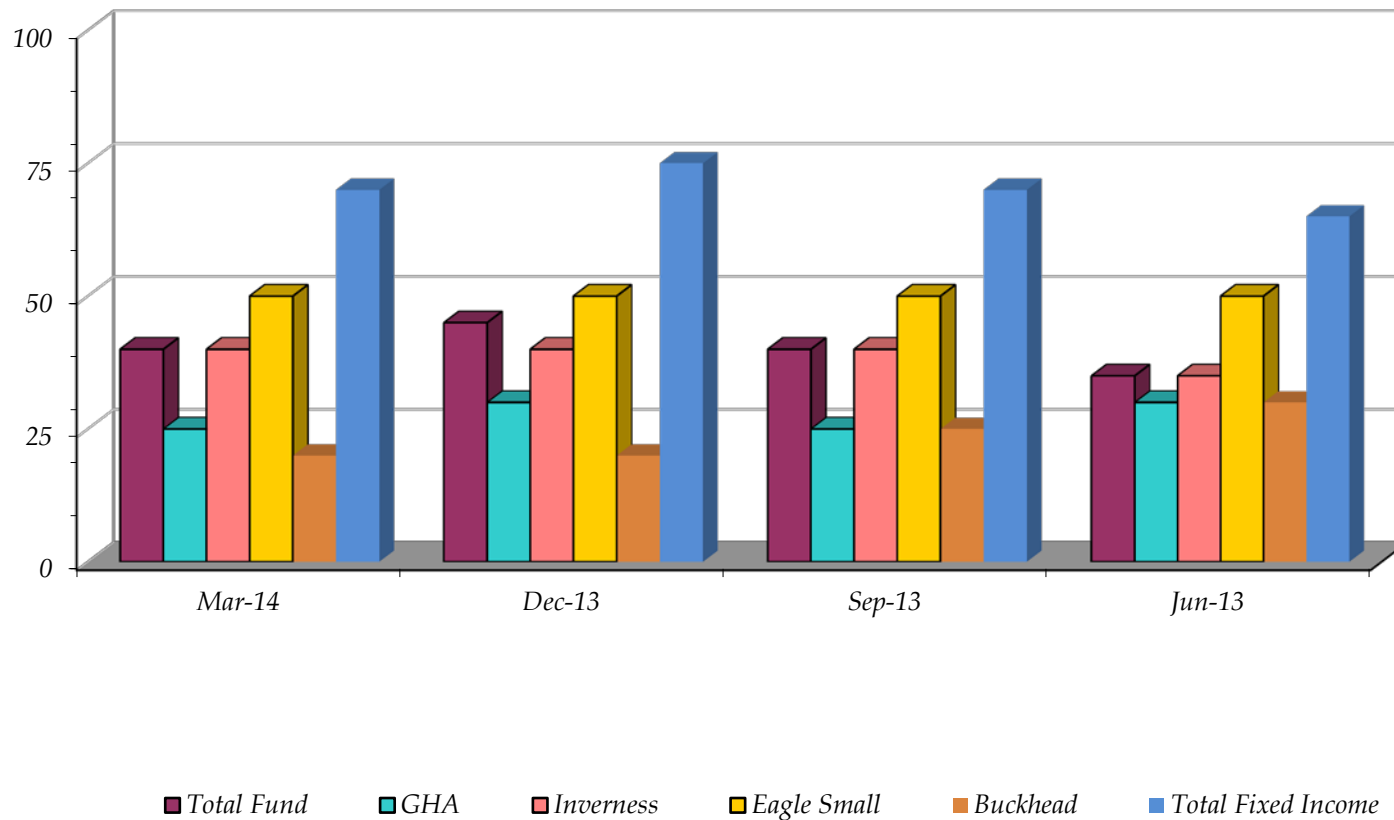
**TOTAL FUND & INDIVIDUAL MANAGERS**
